

## ARP ESSER Health and Safety Plan Guidance & Template

Section 2001(i)(1) of the American Rescue Plan (ARP) Act requires each local education agency (LEA) that receives funding under the ARP Elementary and Secondary School Emergency Relief (ESSER) Fund to develop and make publicly available on the LEA's website a Safe Return to In-Person Instruction and Continuity of Services Plan, hereinafter referred to as a Health and Safety Plan.

Based on ARP requirements, 90 percent of ARP ESSER funds will be distributed to school districts and charter schools based on their relative share of Title I-A funding in FY 2020-2021. Given Federally required timelines, LEAs eligible to apply for and receive this portion of the ARP ESSER funding must submit a Health and Safety Plan that meets ARP Act requirements to the Pennsylvania Department of Education (PDE) by Friday, July 30, 2021, regardless of when the LEA submits its ARP ESSER application.

Each LEA must create a Health and Safety Plan that addresses how it will maintain the health and safety of students, educators, and other staff, and which will serve as local guidelines for all instructional and non-instructional school activities during the period of the LEA's ARP ESSER grant. The Health and Safety Plan should be tailored to the unique needs of each LEA and its schools and must take into account public comment related to the development of, and subsequent revisions to, the Health and Safety Plan.

The ARP Act and U.S. Department of Education rules require Health and Safety plans include the following components:

- How the LEA will, to the greatest extent practicable, implement prevention and mitigation
  policies in line with the most up-to-date guidance from the Centers for Disease Control
  and Prevention (CDC) for the reopening and operation of school facilities in order to
  continuously and safely open and operate schools for in-person learning;
- How the LEA will ensure continuity of services, including but not limited to services to address the students' academic needs, and students' and staff members' social, emotional, mental health, and other needs, which may include student health and food services;
- 3. How the LEA will maintain the health and safety of students, educators, and other staff and the extent to which it has adopted policies, and a description of any such policy on each of the following safety recommendations established by the CDC:

- a. Universal and correct wearing of masks;
- b. Modifying facilities to allow for physical distancing (e.g., use of cohorts/podding);
- c. Handwashing and respiratory etiquette;
- d. Cleaning and maintaining healthy facilities, including improving ventilation;
- e. <u>Contact tracing</u> in combination with <u>isolation</u> and <u>quarantine</u>, in collaboration with State and local health departments;
- f. Diagnostic and screening testing:
- g. Efforts to provide COVID-19 vaccinations to school communities;
- h. Appropriate accommodations for children with disabilities with respect to health and safety policies; and
- i. Coordination with state and local health officials.

The LEA's Health and Safety Plan must be approved by its governing body and posted on the LEA's publicly available website by July 30, 2021.\* The ARP Act requires LEAs to post their Health and Safety Plans online in a language that parents/caregivers can understand, or, if it is not practicable to provide written translations to an individual with limited English proficiency, be orally translated. The plan also must be provided in an alternative format accessible, upon request, by a parent who is an individual with a disability as defined by the Americans with Disabilities Act.

Each LEA will upload in the eGrants system its updated Health and Safety Plan and webpage URL where the plan is located on the LEA's publicly available website.

The ARP Act requires LEAs to review their Health and Safety Plans at least every six months during the period of the LEA's ARP ESSER grant. LEAs also must review and update their plans whenever there are significant changes to the CDC recommendations for K-12 schools. Like the development of the plan, all revisions must be informed by community input and reviewed and approved by the governing body prior to posting on the LEA's publicly available website.

LEAs may use the template to revise their current Health and Safety Plans to meet ARP requirements and ensure all stakeholders are fully informed of the LEA's plan to safely resume instructional and non-instructional school activities, including in-person learning, for the current school year. An LEA may use a different plan template or format provided it includes all the elements required by the ARP Act, as listed above.

\* The July 30 deadline applies only to school districts and charter schools that received federal Title I-A funds in FY 2020-2021 and intend to apply for and receive ARP ESSER funding.

## Health and Safety Plan Summary: Beacon Light Academy

1. How will Beacon Light Academy, to the greatest extent practicable, support prevention and mitigation policies in line with the most up-to-date guidance from the CDC for the reopening and operation of school facilities in order to continuously and safely open and operate schools for in-person learning?

The Beacon Light Academy is committed to providing in-person learning to the maximum extent possible. The school will continue to follow guidance from the Center for Disease Control, the Pennsylvania Department of Health and the Pennsylvania Department of Education.

2. How will Beacon Light Academy ensure continuity of services, including but not limited to services to address the students' academic needs, and students' and staff members' social, emotional, mental health, and other needs, which may include student health and food services?

Continuity of services will continue to be offered with a full day of in person learning along with the implementation of layered prevention strategies.

Student's Academic Needs – remote learning will be addressed through in person visits from Beacon Light Academy teachers to residential units and community students' residence using mini lessons and work packets. Virtual lessons through Study Island will also be offered during remote learning days for additional curriculum support.

Student and Staff Social, Emotional, and Mental Health Needs – student needs will continue to be monitored by teachers, educational support technicians, aides, the school nurse and school psychologist. Staff resources such as the Employee Assistance Program (EAP), are available to all staff.

Food Service Needs – Beacon Light Academy will continue to provide food services for all students. Students will be entitled to one free breakfast and one free lunch each school day during the 2023-2024 school year. The continuity of services will continue regardless of in-person or remote learning.

a. Universal and correct wearing of masks;	Beacon Light Academy will continue to follow CDC, PDE and PADoH's guidance, expectations, and any updates on masking. The agency may decide to implement enhanced masking strategies when there is an outbreak among school personnel or students. Continued training and professional development will be planned and implemented to train students and staff on correct mask wearing.
b. Modifying facilities to allow for <u>physical</u> <u>distancing</u> (e.g., use of cohorts/podding);	Students remain in the same classroom for instruction and meals each school day. Staff and student desks will continue to maintain a distance of three to six feet apart, or as based on active CDC recommendations. All school areas will continue to honor maximum capacity numbers.
c. <u>Handwashing and respiratory etiquette;</u>	Beacon Light Academy will continue to educate students and staff on safe and healthy hygiene practices. This includes both hand washing and respiratory etiquette. Hand sanitizing dispensers have been installed in all classrooms and high traffic areas. Signage has been posted throughout the school illustrating proper hand washing techniques.
d. <u>Cleaning</u> and maintaining healthy facilities, including improving <u>ventilation;</u>	Learning spaces, surfaces, and any other areas used by students are cleaned daily following CDC, PADoH and PDE guidelines. At any time, when safe, and appropriate, ventilation will be increased by opening windows and doors.
e. Contact tracing in combination with isolation and quarantine, in collaboration with the State and local health departments;	The school will continue to follow all legally required mandates and directives by the Pennsylvania Department of Health.
f. <u>Diagnostic</u> and screening testing;	Beacon Light Academy residential students will be screened at the group home prior to arrival at school.  Community students will be screened upon arrival to school. Community student parents will be encouraged to conduct a daily self-check a home for symptoms of illness. Students arriving to

	school symptomatic will be assessed by school nursing staff.
g. Efforts to provide vaccinations to school communities;	Journey Health, IU9, Bradford Schools and Bradford Hospital have offered vaccination clinics to members of the community. The school will continue to share vaccination opportunities for students, staff and the community.
h. Appropriate accommodations for students with disabilities with respect to health and safety policies; and	Beacon Light Academy will provide the appropriate accommodations and adaptations based on the student's IEP and/or guidance provided by the student's health care provider as it relates to their health and safety.
i. Coordination with state and local health officials.	Beacon Light Academy will continue to collaborate and coordinate with state and local health officials for the 2023-2024 school year.
